

DELEGATES RULES AND REGULATIONS

WHO MAY JOIN:

1. Applicant must be a naturally born female of at least 25% Asian ancestry from one of the 58 countries in the Asian Continent and between the ages of 16 to 28 years old.
2. Applicant must be single, of good moral character, never married, with no children and not pregnant during the pageant.
3. Applicant must be talented, charming and with pleasing personality.

IMPORTANT CONTEST RULES:

1. Virgelia Productions, Inc., the Producer of Miss Teen Asia USA Cultural Pageant reserves the right, at its sole discretion, to refuse or reject any applications from a prospective Delegate and to eliminate any Delegate from the Pageant at any time for any violation of the Rules and Regulations. Decisions of the Producer are final. Delegates will be provided with the contract and rules and regulations for the Queen and four Runners-Up at the Delegates Orientation. As a condition of participation in the Pageant, all Delegates must execute this contract prior to the Pageant.
2. Delegates will be judged according to physical beauty, intelligence, poise and personality. Delegates will compete and be judged in Swimsuit, Evening Gown and Personality Interview categories. Each category is weighted equally in the scoring.
3. Delegates will be responsible for selling 30 tickets to the Pageant and (3) full pages of advertisements in the Miss Asia USA Official Magazine. All advertisements must be approved by Virgelia Productions, Inc. and full payment must be received 20 days before the pageant. Delegates must provide Virgelia Productions, Inc. with a short written personality profile and photograph to be included in the Miss Teen Asia USA Official Magazine.
4. Delegates are responsible for their own required wardrobe to be worn during the Pageant. The required wardrobes are: (i) black business suit; (ii) national costume; (iii) swimsuit (iv) evening gown. All wardrobes must comply with the Miss Asia USA wardrobe guidelines. These guidelines will be announced during the Delegates Orientation. Delegates are requested to bring a gift that best represents her culture for the gift exchange of the Delegates.
5. Delegates must be accompanied by guardian or parents during Delegate's Orientation.
6. Delegates are responsible for their own transportation and accommodations on the day of the Pageant.
7. Delegates must be present during the Presentation of Delegates and the Swimsuit Pictorial. Delegate must attend all rehearsals. There will be an elimination process as rehearsals progress. On the pageant day, all Delegates must arrive at 8:00 AM at the venue. Delegates must prepare their hair and make-up at the venue's dressing rooms. You should make arrangements to bring along your own stylist. Each Delegate may bring in only (1) chaperon inside the dressing room. Delegates must not bring or invite anyone else inside the dressing room.
8. Virgelia Productions, Inc. is not responsible for any lost, stolen or damaged property of the Delegates, their friends or families.
9. Five winners will be chosen at the Pageant. All cash and gift prizes are awarded subject to complete fulfillment of the winner's obligations during their respective reigns. Miss Asia USA-Queen will receive a combination of cash and gift prizes with a retail value of Five Thousand Dollars, including scholarships,

(1) round trip ticket to any Asian country of the Queen's choice and other gift certificates. The First Runner-up will receive a combination of cash and gift prizes with a retail value of Two Thousand Dollars, including scholarships and other gift certificates. The Second Runner-up will receive a combination of cash and gift prizes with a retail value of One Thousand Dollars, including scholarships and other gift certificates. The Third and Fourth Runners-up will each receive a combination of cash and gift prizes with a retail value of One Thousand Dollars including a scholarship and other gift certificate. Virgelia Productions, Inc. reserves the right to distribute the prizes at any time within twelve (12) months from the Pageant day. All prizes/gifts are provided to Virgelia Productions, Inc. by sponsors of the Pageant and are subject to any conditions and restrictions imposed by such sponsor. If any sponsor elects, in their sole discretion, to cancel or modify the prizes/gifts they have agreed to provide, then the prizes/gifts will be so cancelled or modified without any given notice. Virgelia Productions, Inc., including its employees, sponsors and agents, shall not be held responsible or liable for modified or cancelled prizes/gifts or any other actions by the sponsors or the grantor of these prizes. Taxes on prizes/gifts are the winner's sole responsibility.

The Miss Asia USA queen will reign for one year, during which she cannot participate in any other pageant, or any similar events without first obtaining the express written consent of Virgelia Productions, Inc. The Queen and all Runners-Up must strictly comply with the Winner's Contract and Rules and Regulations. Failure to comply will result in dethronement. If a Winner is dethroned or choose not to continue her reign, all prizes, including crown, sash and trophy, must be immediately returned in the same condition as it was when received. If any Delegate or the winners disparages, defames, libels or slanders the Pageant, Virgelia Productions, Inc., including its employees and agents, any sponsors, contractors, any judge, advertisers, committee members or any volunteers, then such Delegate shall be eliminated from the Pageant or dethroned and stripped of her title and prizes, as the case may be. Virgelia Productions, Inc. is the registered trademark holder and owner of the title Miss Asia USA and reserves and retains all rights, title and interest therein. Use of the title of Miss Asia USA is strictly prohibited without the express written consent of Virgelia Productions, Inc. If at any time during her reign the queen is unable to fully perform her duties, she is subject to dethronement. Should the Queen be dethroned or she relinquishes her title before the end of her reign, all prizes, including crown, sash and trophy must be returned to the Virgelia Productions, Inc. within ten (10) days in the same condition it was given to her.

11. All tabulation results, including all judges' scoring sheets, are the property of Virgelia Productions, Inc. All tabulation results, including judges' scoring sheets, are proprietary trade secrets and are strictly confidential. The final results are not subject to challenge and all Delegates, including any of their representatives, hereby voluntarily waive any right to challenge or otherwise contest the results of the Pageant. Any questions regarding to the scoring system must be raised at least one week prior to the Pageant.

Neither Virgelia Productions, Inc. and its employees and agents, nor any promoters, entertainers, judges, staff, volunteers, advertisers and Sponsors of Miss Asia USA shall not be liable for any sickness, injury or accidents suffered by any Delegate or her accompanying parties before, during and after any events or rehearsal. Delegates are required to sign a Hold Harmless Agreement with Virgelia Productions, Inc.

13. All applications must be accompanied by: 1) \$600.00 non-refundable entry fee; 2) Two 5X7 Professional Photographs; 3) a signed copy of completed application; and 4) a signed copy of the Rules and Regulations All payments are payable to Virgelia Productions, Inc. Incomplete applications will not be considered.

14. Virgelia Productions, Inc. reserves the right to amend or supplement the Rules & Regulations at any time. Written notice of such changes shall be provided. 🍷

I agree to abide by them and all other terms and conditions of the Pageant and affix my signature below as evidence of my acceptance thereof. I further agree to provide Virgelia Productions, Inc within 48 hours of receipt of notice, all information and evidence requested of me to establish my compliance with all rules, regulations, terms, conditions and restrictions of the *Miss Asia USA* Pageant. I further agree that I shall have no contact, direct or indirect, written or oral, with any of the judges prior to the Pageant. I agree that I release and relinquish forever, any claims to legal or equitable relief arising from this agreement or directly or indirectly arising from the *Miss Asia USA* Pageant or Virgelia Productions, Inc. I agree that I shall not disparage, defame, libel or slander Virgelia Productions, Inc., *Miss Asia USA*, sponsors, judges, producers, staff, volunteers and committee members or anyone connected with the Pageant. I understand that my obligations commence upon signing the contract and remain in effect before, during and after the Pageant. My failure to comply with the rules and regulations of *Miss Asia USA* shall subject me to disqualification from the Pageant and forfeiture of any title and prizes associated therewith.
